#### **EUPHA 2001: ANNUAL CONFERENCE**

The 2001 EUPHA conference was held in Brussels from 6 to 8 December. The main theme was health information systems throughout Europe and their interaction with public health policy development and actions. There were 40 parallel sessions and workshops organised around the plenary ones, on topics ranging from mental health to health in transition countries. All 5 EUPHA sections organised one or more workshops in their different fields.

It is clear that the central location of the conference was an invitation for international research groups and projects to meet at the same time. The local organisers managed to reserve an extra room for these groups to meet, making the EUPHA conference a true social meeting place for public health in Europe. The central location also boosted the registration: there were 530 participants.

For the second time, the Open Society Institute of the SOROS foundation funded presenting authors from central and Eastern Europe. The grant from the SOROS foundation was an incentive for experts from this region to submit abstracts, as a clear increase in abstracts submitted from these countries could be seen.

The EUPHA poster prize was awarded for the second time; this time to Dr Sverker Nilsson from Varberg, Sweden for his poster entitled: An appearance programme to prevent the misuse of androgenic anabolic steroids among male adolescents. For the first time, EUPHA also awarded a best abstract prize to Dr Michelle Kruijshaar from Rotterdam, Netherlands for her abstract: The burden of breast cancer in six European countries: the European Disability Weights project. Both prizes consist of a waiver of conference fees for the year after.

#### EUPHA 2001: THE EUROPEAN JOURNAL OF PUBLIC HEALTH

The European Journal of Public Health (EJPH) is published four times a year and sent to all our individual members. The EJPH is a multidisciplinary scientific journal aimed at attracting contributions from epidemiology, health services research, management, ethics and law, health economics, social sciences and environmental health. It provides a forum for discussion and debate of current international public health issues with a focus on the European region. It contains refereed original articles, editorials, commentaries, book reviews, news, letters to the editor and announcements of events. The impact factor of the EJPH is now 1.16.

The number of submitted manuscripts has again increased. In the year 2001, 216 manuscripts were submitted of which 103 were rejected. 88 are still in process and 25 were accepted for publication. The average time from submission to publication went down to 17.5 months (compared to 23.5 in the beginning of the year 2001).

The EUPHA internal working group on EJPH 2002 onwards is setting up a detailed proposal to improve the journal's visibility and professional character. This proposal could include increasing the number of issues to 6 per year and offering online translations of the abstracts of the articles.

#### **EUPHA 2001: ACTIVITIES OF THE EUPHA SECTIONS**

#### Section on health promotion

#### Presidents: Heiko Waller and Alf Trojan

The section on health promotion organised a workshop at the Brussels conference on health information (systems) for health promotion with 5 presentations. The presidents of the section have also presented EUPHA at a number of conferences/meetings, such as the XVII world conference of health promotion and health education organised by the International union for health promotion and education in Paris (15-20 July) and the conference "The role of social services for a sustainable social development" organised by the Council of Europe and the Ministry of Family in Berlin, 25-26 October 2001. For the coming year, the section is planning another workshop at the Dresden conference and further representative tasks for EUPHA in the international health promotion network.

#### Section on public health policy and practice

#### Presidents: Mark McCarthy and Nils Rosdahl

The section on public health practice and policy organised a workshop at the Brussels conference on public health information systems with 5 presentations. Furthermore, the presidents of the section have been very active in the negotiations with the European Commission and have commented for EUPHA on the health forum consultation of DG Sanco and the EU 6<sup>th</sup> Research programme. For the year to come, the section will continue to develop the public health practitioners' side both within EUPHA and within the European Union.

#### Section on epidemiology

#### President: Klim McPherson

The EUPHA section on epidemiology organised two workshops at the Brussels conference. One on Life course epidemiology and health inequalities (3 presentations) and the other on "Towards modern public health – the relevance of social capital" (3 presentations).

#### Section on health services research

President: Jouke van der Zee (until December 2001), Diana Delnoij (from December 2001 onwards) The EUPHA section on health services research took up its activities again by organising an interactive workshop at the Brussels conference on integrated care. At the same time, a new president - Diana Delnoij, a senior researcher at the Amsterdam Medical Centre - was elected.

#### Section on social security and health

#### President: Kristina Alexanderson

The section on social security and health organised a workshop at the Brussels conference on physician's sickness certification practice with 4 presentations. This workshop was followed by the section meeting in which the plans for the coming years were discussed.

#### Section youth

#### President: Auke Wiegersma This new EUPHA section was installed at the meeting of the EUPHA Governing Council during the Brussels conference.

#### Section food and nutrition

President: Sirpa Sarlio-Lähteenkorva

This new EUPHA section was also installed at the meeting of the EUPHA Governing Council during the Brussels conference.

#### **EUPHA 2001: OTHER ACTIVITIES**

EUPHA is very pleased to welcome our new members in 2001: the Icelandic Association of Public Health, the Malta Association of Public Health Medicine, Dr David Ruslan, individual member from Moldova, the Netherlands Public Health Federation, replacing the existing Dutch members, the Slovenian Preventive Medicine Society and the UK Faculty of Public Health.

One of the main activities for 2001 was to elaborate a change of bylaws, which was accepted by the EUPHA Governing Council at their December meeting. The change of bylaws will enable EUPHA to

set up different kinds of public health reports, ranging from statements (elaborated by a small group of experts) to EUPHA reports (to be adopted by the Governing Council). The change of bylaws also allows EUPHA to set up more EUPHA sections.

The EUPHA office was reorganised and plans for the mid- and long-term were set up by two working groups. Both working groups have been active in 2001 and have proposed future scenarios to the Governing Council at the December meeting. The group on the future of EUPHA formulated some clear directions for EUPHA's future activities. The working group EJPH 2002 onwards proposed changes to the EJPH, its relation with EUPHA, its way of publishing, etc. In the coming year, these proposals will be further elaborated and implemented.

The relationship with the SOROS foundation was further developed. This year, 36 public health experts from central and Eastern European countries could be funded by the Open Society Institute of the SOROS foundation, a clear increase from last year (28 participants).

EUPHA has made serious efforts to include the public health practitioners more into the EUPHA network. The most important effort was made in the planning of the 2002 conference in Dresden, Germany, where the procedure of submission of public health practice abstracts will be simplified. We hope that this will lead to a clear increase in abstracts submitted on these subjects and thus a better presentation of the public health practice side at the 2002 conference.

#### **EUPHA 2001: NETWORKING**

EUPHA has intensified its networking with some of the other European governmental and nongovernmental organisations.

ASPHER:	With the Association of Schools of Public Health in the European Region (ASPHER),
	we have increased our collaboration. EUPHA has obtained associate membership with ASPHER, a status which EUPHA had already granted to ASPHER. Furthermore,
	plans were developed to set up joint conferences. We are now working on the
	practical implementation of these plans. Lastly, EUPHA was asked to join in the
	project of ASPHER-Fondation Mérieux on quality improvement and accreditation of
	training programmes in public health.
EPHA:	With the European Public Health Alliance (EPHA), we only had contacts through our
	participation in the public health platforms meetings, organised by EPHA.
WFPHA:	We were present at the annual meeting of the World Federation of Public Health
	Associations (WFPHA) in May in Geneva, Switzerland. Collaboration is planned with
	their tri-annual conference in 2004, to be held in the United Kingdom. Representatives
	of the WFPHA were present at our Brussels meeting.
WHO:	Thanks to the Brussels conference, we have had several contacts with the World
	Health Organisation (WHO), both their regional office in Copenhagen, the
	headquarters in Geneva and the European Union liaison office in Brussels. A large
	representation of the WHO was present at the Brussels conference.

	Commission: they organised several workshops during the conference and a large

#### **EUPHA 2001: FINANCES**

EUPHA's resources are coming from membership fees, the profit share of the EJPH, the annual conferences and the Dutch Ministry of Health, which has agreed to sponsor EUPHA again in the year 2002.

EUPHA's expenses are the EJPH and the EUPHA office. The costs of the EJPH have again increased. This was necessary to support an increase in the number of pages per issue to overcome the backlog in documents. The costs of the EUPHA office have decreased.

At the moment, EUPHA is only self-sufficient for 60% of its budget. This is not enough and solutions will have to be found. These solutions will have to be aimed at increasing the income side, as it is difficult – for the time being – to decrease the expenses side.

#### **EUPHA 2002 ONWARDS: CONFERENCES**

The 2002 EUPHA conference will be held in Dresden from 28 to 30 November. The main theme of the conference is "Bridging the gap between research and policy in public health: information, promotion and training". The local organisers have had extensive contacts with possible partners and sponsors, including the German Health Ministry, the German Research Ministry, the Saxony Health and Research ministries and the Health directorate of the European Commission. The Saxony Research Ministry agreed to support travel costs for central and Eastern European participants. Furthermore, the SOROS foundation has agreed to fund central and Eastern European presenters.

The 2003 EUPHA conference will be held in Rome, Italy from 20 to 22 November. The main theme is "Globalisation and health in Europe: harmonising public health practices", which will help EUPHA to develop the ties with public health practitioners even more. Three sub-themes are proposed: public health actions to tackle consequences on health of man-made disasters; food safety in Europe; and globalisation and health services management.

The 2004 EUPHA conference will be held in Oslo, Norway from 21 to 23 October. The main theme is "Urbanisation and health – new challenges in health promotion and prevention".

The EUPHA conferences are based on a rotation schedule (South, North, East, West) and EUPHA plans to follow the schedule listed below:

- 2005 Eastern Europe
- 2006 Western Europe
- 2007 Southern Europe
- 2008 Northern Europe
- 2009 Eastern Europe
- 2010 Western Europe

For EUPHA members interested in organising an annual EUPHA conference, the EUPHA office has set up a conference scenario, containing planning, finances and other organisational information on how to apply for and organise an EUPHA conference.

#### EUPHA 2002 ONWARDS: PLANNED ACTIVITIES

For 2002, EUPHA is planning the following activities:

- Celebration activities for EUPHA's 10<sup>th</sup> anniversary. We will publish president's columns, not only from the current president but also from past and future presidents in the EJPH. At the Dresden conference, one plenary session will be dedicated to 10 years of EUPHA. Other activities are being planned.
- A more active search for public health experts to be included in the EUPHA database. The EUPHA database now holds over 4500 addresses, but does not yet include the expertise of

the people included. The active search, aimed to also include this expertise, may allow EUPHA to set up 'expert statements' on various public health issues.

- A new EUPHA homepage, which is intended to include all relevant information on EUPHA, European research initiatives, conferences, but also country-related information. We hope that this homepage will be THE starting page for public health experts in Europe.
- More emphasis on public health practitioners. Here, we have already developed initiatives. First, our very active section on public health practice and policy is putting this issue on the public health agenda. Second, the guidelines for the submissions of abstracts to the EUPHA conferences have been adapted. For Dresden, abstracts can be submitted either as a research abstract (which was always the case) or as an abstract on public health practice, health information system or health care reforms. This is a big step to strengthen the exchange of public health experiences (evidence-based) at the EUPHA conferences.
- Expansion of the activities of the EUPHA sections and encouragement of the development of new EUPHA sections. This activity aims to include our individual members more directly in the activities of EUPHA.
- Active membership hunting. There are still a number of countries whose public health associations are not yet a member of EUPHA. We will continue our activities in this direction.

#### **EUPHA 2002 ONWARDS: FINANCES**

As stated above, EUPHA is only self-financing for 60% of its budget, which is not sustainable in the long run. EUPHA is very pleased that the Dutch Ministry of Welfare, Health and Sport has agreed to sponsor the EUPHA office for the year 2002.

In 2002, EUPHA has to consolidate its finances. Options are: to increase the number of sponsors, to find long-term sponsors, to increase the number of members, etc. Several plans were proposed in 2001 and should be implemented in 2002.
