Health inequalities in the EU -- Final report of a consortium

A report has been published outlining new evidence on health inequalities in the European Union (EU) and the policy response at EU and national level to health inequalities since 2009.

The report:

• Confirms significant inequalities in health between and within EU Member States, which for the most part are similar to those identified in 'Health inequalities: Europe in profile' (2006). Some

inequalities have increased, while others have decreased, suggesting that significant headway has not been made in the EU in reducing health inequalities.

- Demonstrates marked differences in the social determinants of health in turn caused by the existence of marked social inequalities across EU Member States and inequalities in health between social groups based on these determinants.
- Examines the factors causing health inequalities. Like the WHO CSDH, this report agrees that health inequalities result from social inequalities in the conditions of daily life and their fundamental drivers (e.g. early childhood, employment conditions, social spending and protection, etc.) that give rise to them.
- Presents research showing the policy response to health inequalities in EU member states and regions. Countries' responses are characterised as having a: 1) Relatively positive and active response, 2) Variable response, 3) Relatively undeveloped response to health inequalities. These results, including those showing that serious headway has not been made in tackling health inequalities in EU countries, justify the headline conclusion of the WHO Europe report which was that all countries can *do something* to improve the social determinants of health, *do more*, or *do better* with their existing policies and spending. Worryingly, the research suggests a widening of the policy response across EU member states since 2006.
- Provides a comprehensive set of recommendations for the European Commission, and individual member states and regions.

Smoking is one of the most important modifiable risk factors for the development of cardiovascular disease. The Dutch Heart Foundation and the European Heart Network (EHN) have drafted a statement advocating the introduction of legislation on plain packaging - neutral tobacco product packaging. By signing the statement you help putting plain packaging on the agenda and possibly with the realization of plain packaging legislation throughout Europe. Plain packaging is an effective method to reduce the appeal of cigarettes, to make quitting smoking easier, and to have less young people start smoking altogether. The report argues that we need a coherent conception of a 'European Social Union'. It provides a comprehensive survey of the development of the social dimension in European cooperation, and defines ten key questions that have to be tackled with a view to developing this Social Union. *Friends of Europe* has convened a High-Level Working Group to tackle some of these issues in the course of 2014, with the ambition to take the EU's social dimension out of its 'specialist-only' corner and to bring these social concerns to the top of the political agenda. The winners were announced by Health Commissioner, Mr Tonio Borg, at an award ceremony in Brussels on the 8th of April. Out of more than 850 articles entered into the competition, 28 national finalists were chosen by juries in each EU country. Amidst the shortlist of 28 excellent articles, the winners are:

1st place: Henk Blanken writing for Dagblad van het Noorden (the Netherlands) for his article "Carel's Head", a story which follows a young man suffering from Parkinson's disease from diagnosis to treatment, and gives a detailed and emotional account of the pioneering surgery he receives.

2nd place: Christiane Hawranek and Marco Maurer, writing for Die Zeit (Germany) for their sharp, 'documentary-style' article "The Patient Traffickers" which highlights dubious practices in non-regulated medical care across borders.

3rd place: Mette Dahlgaard writing for the Berlingske newspaper (Denmark) for "Am I Killing Someone?", the story of a sperm donor who discovers that he carries the gene for a highly hereditary form of cancer, but hits a brick wall when he tries to find a way of warning potential children who could be affected.

New data on antibiotic use in European Region

20-03-2014 WHO/Europe and the University of Antwerp, Belgium have made the first collection and analysis of data on antibiotic use in 13 countries and areas in eastern Europe and central Asia. This research is vital to address the challenge of antibiotic resistance.

Four-fold difference in antibiotic consumption across the European Region – new WHO report 17-03-2014 A new report1 published in The Lancet Infectious Diseases on 20 March 2014, is the first to release data on total antibiotic consumption for countries outside the European Union (EU). The data (from 2011) indicate an almost fourfold difference between the lowest and the highest antibiotic users among 42 countries and regions in the WHO European Region (within and outside the EU), and provide a clear picture of the use of different groups of antibiotics.

WHO revising sugar guidelines 06-03-2014 WHO is holding a public consultation on draft guidelines on sugar intake on 5–31 March 2014; it is open to anyone submitting a declaration of interest. After the consultation and peer review, the guidelines will be finalized; they will provide countries with recommendations on limiting the consumption of sugars to reduce public health problems such as obesity and dental caries.
