## 2. EUPHA update

### EUPHA president supports editorial freedom

Dear Sirs,

I write as President of the European Public Health Association, representing over 17,000 public health professionals across Europe. We understand that a complaint has been made against Dr Richard Horton in respect of a letter he recently published in the Lancet on the situation in Gaza. I write on behalf of the association to offer our full support for Dr Horton. We do not take a collective view, as an association, on the situation in Israel and Gaza. However, we are very concerned at any threat to Dr Horton who, in our view, has led the Lancet to a position where it is now the most respected international medical journal and the premier forum for discussions on global health. We know Dr Horton to be someone of the highest integrity, committed to the welfare of humanity. We note that the Lancet has published online many responses to the letter in question, many of which take a contrary view, something we regard as *prima facie* evidence of balance. To lose him would, in our view, cause the Lancet inestimable damage as it would signify that the publishers were giving in to what, in our view, is an entirely unjustified attack on editorial freedom.

**2014-IPR-I-40-000-3515 - Cancer Information System**

The Joint Research Centre (JRC) is the European Commission's in-house science service. In 2013, its institute for Health and Consumer Protection established a Public Health Policy Support Unit to address priority activities such as nutrition, behavioural economics, surveillance (medical devices), healthcare quality and health information on rare diseases and cancer.

With regard to the latter, the JRC is facilitating and coordinating the creation of a cancer information system for Europe. This will channel past and existing experiences and competences in a neutral environment (JRC) which will provide sustainability and continuity. Support to, and cooperation with, Europe's cancer registries will be the key towards improving the quality, reliability and comparability of cancer data. The comparison of data via epidemiological analysis will be used to steer public health policy making and will provide an evidence base for understanding the effectiveness of cancer diagnosis, treatment and follow-up.

The tasks assigned to the successful candidate would include:

1. collaboration with all relevant stakeholders, partnerships, and scientific networks related to the establishment of the cancer information system
2. supporting the JRC team in the activities necessary for setting up a database architecture enabling management of datasets from cancer registries and their subsequent analysis
3. publication of reports and peer reviewed papers.

**2014-IPR-I-40-000-3473 - ECIBC (European Commission Initiative on Breast Cancer)**

The Institute for Health and Consumer Protection established in 2013 a Public Health Policy Support Unit to cover several horizontal aspects of public health, like nutrition, behavioural economics, surveillance (medical devices), disease data (cancer registries and rare disease registries) and healthcare quality.

For this last horizontal aspect, a project was started in 2012 on breast cancer (the European Commission Initiative on Breast Cancer - ECIBC) which aims to (i) update the existing screening guidelines, (ii) create a platform for guidelines for other stages of care, and (iii) establish a set of European evidence-based standards for breast cancer care (a voluntary accreditation scheme for breast cancer services).

The successful candidate will have to support the team in all the core and side activities related to the project, including, e.g.:

1. Advising and contributing to the knowledge base of the team in the requested fields of competence (see below under "Requirements")
2. Updating the networking horizon, including HORIZON 2020 and other related on-going projects
3. Organising bi-lateral and plenary meetings with stakeholders
4. Contributing to preparation of documents related to working groups management (terms of reference, conflict of interest management, invitations and agendas, supporting documents management, etc.)
5. Updating of project web-pages and of any ECIBC information source available to public
6. Publication of reports and peer reviewed papers in the initiative domains

The successful candidate will have also to establish collaborations with relevant stakeholders and provide support to the team leader in granting that the oncological side of the project is correctly planned and coordinated.

**Request for participation in survey for The Teaching and Learning Health Policy and Systems Research Thematic Working Group of Health Systems Global**

The Teaching and Learning Health Policy and Systems Research Thematic Working Group of Health Systems Global in collaboration with the World Health Organization's Alliance for Health Policy and Systems Research is conducting a mapping study with the goal of identifying current training programmes with a focus on health policy and systems research relevant to low- and middle-income countries. They aim to capture the diversity of these courses in terms of content and modalities to suggest opportunities for expansion and for further development of training around health policy and systems research.

As an emerging area of research, health policy and systems research asks questions that relate to real-world situations and issues that focus on health services and promoting health. It supports applied research that explicitly seeks to influence policy and has potential to lead to health system development. Health policy and systems research is seen as particularly well-suited to answer why and how a certain combination of structures, policies, or interventions may have shaped outcomes. It can draw on one or more disciplines and methods to answer these questions.

The Teaching and Learning Health Policy and Systems Research Thematic Working Group of Health Systems Global would appreciate it if you could answer some questions about health policy and systems research courses in which you are involved. ## **9. European Commission news**

### **How are breast cancer care services organised in Europe?**

The JRC published a comprehensive report of breast cancer care services in Europe based on a survey which analysed the current situation in 25 countries that voluntarily participated in the study. This report is a major step towards the development of a European quality assurance scheme for breast cancer services, which is part of the [European Commission Initiative on Breast Cancer](#) coordinated by the JRC.

The '[Report of a European survey on the organisation of breast cancer care services](#)' covers healthcare organisation, cancer screening, breast cancer care organisation, safety and quality, accreditation and certification schemes, competence requirements for professionals and much more.

The survey results illustrate a diversity of healthcare systems, showing that:

- healthcare services are public in the majority of participating countries (88%);
- independent of the respective country's healthcare system, breast cancer care services can be organised along different models (e.g. one central body or multiple collaborating entities to cover all the stages of breast cancer care); at least seven models are represented in participating countries;
- a national, standardised education path for breast cancer specialists is available in 64% of countries for physicians and in less than 50% for nurses and paramedical staff;
- screening programmes for breast cancer are available in 22 countries, for cervical cancer in 18 countries and for colorectal cancer in 14 countries;
- only half of the participating countries have at least one kind of quality assurance system for breast cancer services in place (e.g. private or public, national, local or hospital-based).

The European Commission supports the development of a modular, flexible and evidence-based scheme, adaptable to the diverse healthcare organisational settings, ensuring all women in Europe get access to quality care.

### **Rapid risk assessment: Outbreak of Ebola virus disease in West Africa**

The outbreak of Ebola virus disease (EVD) in West Africa with onset in early December 2013 in Guinea now involves three countries: Guinea, Liberia and most recently Sierra Leone. This is the first documented EVD outbreak in these countries. By week 14 of 2014, it looked like the control measures would bring the outbreak to a halt but the situation has now evolved in another direction. In week 22 of 2014, there was an unexpected surge in the number of new cases and the outbreak spread to previously unaffected areas in Guinea and Sierra Leone.
