# ECCO: Questionnaire future coordination of cancer research in Europe



ECCO, the European CanCer Organisation, would like the members of EUPHA to provide input to an important questionnaire that will pave the way for future coordination of cancer research in Europe. The questionnaire aims to elicit feedback from the oncology community on areas and infrastructures in which European coordination of research efforts is needed. The answers from this questionnaire will provide the foundations for the ECCO-led Work Package 8 of the European Partnership for Action Against Cancer (EPAAC), a 3-year project supported by the European Commission, aiming at tackling the growing burden of cancer in the EU.

EPAAC's Work Package 8 (cooperation and coordination of cancer research), focuses on 3 specific objectives:

- 1. To identify and prioritise areas in cancer research that will benefit from coordination.
- To develop a concerted approach for coordination of one third of research from all funding sources by 2013. (N.B. This will require the development of a coordination approach that ensures that national decisions are taken based on a joint EU-wide understanding in order to avoid duplication of efforts).
- 3. To implement pilot projects of research coordination in selected areas.

In order to gather the views of the oncology community regarding areas of cancer research and research infrastructures that may benefit from coordination at the European level, a questionnaire has been put together that contains some priority areas as well as infrastructures within the cancer continuum that were suggested by a select group of oncology stakeholders. We kindly ask you to indicate if you agree with the priorities listed within your field of expertise and specify other areas or infrastructures you think are missing, justifying them in terms of the added value that European coordination would bring.

The results of this questionnaire will be presented to major research funding bodies in Europe and subsequently pilot projects as well as plans for future trans-national cancer research projects will be defined in selected areas. Needless to say your contribution will be crucial for the development of effective cancer research coordination initiatives.

Please note that all answers will be treated in the strictest confidence. Deadline for filling in the questionnaire is 25th January 2012.

Launch of the European Urban Health Indicators (EURO-URHIS 2) project: Be the first to view the data and influence future plans

The EURO-URHIS 2 project has received funding from the European Union's Seventh Framework Programme (FP7/2007-2013) under grant agreement number 223711. The EURO-URHIS 2 consortium is led by Dr Arpana Verma (MUCH, University of Manchester) who is the principal investigator for the €3.6million grant.

The EU Public Health Programme work plan 2005 identified the development of an urban health indicator system as an essential part of a comprehensive and integrated EU health information and knowledge system. Based on this, EURO-URHIS 2 is developing, testing and validating a set of comparable urban health indicators (building upon the work already completed by EURO-URHIS 1 and other related projects) in over 40 cities across the European Union and beyond.

On 31<sup>st</sup> January and 1<sup>st</sup> February 2012, we are inviting people with an interest in urban health to attend a 2 day workshop and scientific advisory group meeting to view and discuss initial results from Phase 1 of the EURO-URHIS 2 project.

# Governing public hospitals. Reform strategies and the movement towards institutional autonomy

(Edited by Richard B. Saltman, Antonio Durán and Hans F.W. Dubois)

Governance of public hospitals in Europe is changing. Individual hospitals have been given varying degrees of semi-autonomy within the public sector and empowered to make key strategic, financial, and clinical decisions themselves. This study explores the major developments and their implications for national and European health policy.

The study focuses on hospital-level decision-making and draws together both theoretical and practical evidence. It includes an in-depth assessment of eight different country models of semi-autonomy, in the CzechRepublic, England, Estonia, Israel, the Netherlands, Norway, Portugal and Spain. The evidence that emerges throws light on the shifting relationships between public-sector decision-making and hospital-level organizational behaviour and will be of real and practical value to those working with this increasingly important and complex mix of approaches.

The eastern part of the WHO European Region has the fastest growing HIV epidemic in the world, with the number of people living with HIV estimated to have tripled since 2000. Progress in the western part of the Region shows what can be achieved, though much more is still needed. The overall objective of the European Action Plan for HIV/AIDS 2012–2015 is clear: to ensure zero new HIV infections, zero discrimination and zero AIDS-related deaths in the Region.

The primary audience for the European Action Plan for HIV/AIDS is the national authorities in the Region responsible for HIV diagnosis, prevention, treatment, care and support, including health ministries and other government bodies responsible for health. The Action Plan is also intended for national authorities and ministries other than those directly responsible for health, including finance, education, social welfare, child protection, transportation, infrastructure, criminal justice, labour, immigration, development, defence, and foreign affairs, as well as associations, professional bodies, researchers, academics, civil society, advocacy groups, trade unions, the private sector, and international and global partners, including bilateral and multilateral donors.
