The European health report 2009. Health and health systems

Investing in health and health systems is especially important during times of crisis, such as the severe economic crisis and pandemic (H1N1) 2009 influenza. To address these issues, governments and policy-makers need information that is current, accurate, comparable and user-friendly. What were the trends in public health indicators over the last four years? What factors influence health, and what are the challenges for the future? What contribution can health systems make to improve population health in the WHO European Region? In addressing these questions, this report illustrates the wide-ranging reforms countries have undertaken to strengthen performance in four core functions of health systems: service delivery, resource generation, financing and stewardship.

This report presents essential public health information to support countries in choosing sound investments in health. It should encourage the successful implementation of effective health system reforms and policies, and help countries improve their health systems' performance to provide efficient, patient-centred, high-quality health care. 6. European Commission: information, calls, tenders

(A) Call 2010: New funding opportunities in health.

The European Commission has published the Work Plan for 2010 for the implementation of second programme of Community action in the field of health.

The publication of the Work Plan was followed by the calls for proposals. The Executive Agency for Health and Consumers (EAHC) published calls for proposals for projects, operating grants, conferences and joint actions.

The financial contributions may, where appropriate, include joint financing by the Community and one or more Member states or by the Community and the competent authorities of other participating countries.

The Calls present new funding opportunities for the European organisations active in the area of public

health. The total budget available for the execution of the 2010 Work Plan is 47.1 million euro.

All proposals should address important problems in the European public health and be in line with the Commission's priorities expressed in the Work Plan.

The successful proposals should concentrate on aspects of public health that cannot be achieved on a national level. They should ensure a significant impact across the EU.

The deadline for submission of proposals is 19 March 2010.

(B) Call for proposals to develop and coordinate a network of nursing educators and regulators - Deadline 31 March 2010

The objective of this call for proposal is to create a pilot network of nurse educators and regulators in order to exchange best practices and thus to improve the qualifications of healthcare workers, healthcare assistants and lower-skilled nurses.

There is a need to examine and find solutions to the current employment situation in the health sector, particularly in relation to professional qualifications and duties carried out by healthcare workers, healthcare assistants and lower-skilled nurses and to examine the effects of cross-border mobility both in the host country and the country of origin.

This has synergy with the topics contained in the Commission's Green Paper on the European workforce for Health which started a process of detailed consideration of health workforce planning and supply and the impact of health worker mobility within Member States and within the EU.

(C) Mobility of researchers

Stimulating knowledge exchange through mobility of researchers has become a key priority to national and European policy makers. However, a lot is still not fully understood and more evidence is needed to develop effective policies on this topic. To this end, the European Commission has launched a large scale study (known as the MORE-study - www.researchersmobility.eu) focusing on mobility patterns and career paths of researchers.

We would like to invite you to participate to our survey (about 10-15 minutes of your time) in order to collect your experiences with respect to mobility. Your opinion on the problems, needs and attitudes will help the European Commission (and other Governments) to develop better targeted policies on this subject.

All completed surveys shall remain strictly private and confidential and shall only be used for the purposes of this study.

Ensuring quality in public health microbiology laboratories in the EU: Quality control and areas in need of strengthening

In September 2009, ECDC convened a meeting of its National Microbiology Focal Points (NMFPs), a group of experts that provide technical and strategic input on overarching questions in microbiology.

During the meeting, representatives from national and international quality assurance organisations explained the relevant systems and structures currently in place, and the participating NMFPs elaborated on the quality assurance systems in use in their countries. The participants agreed that ECDC could promote quality assurance by reinforcing collaboration, stimulating the exchange of good practices, and by providing relevant information resources.
