WHO - submission of proposals

to support implementation research that contributes to the scale-up of effective health interventions related to MDGs 4, 5 and 6 in one of the three priority areas described in the following section. The research proposals may be submitted for one of the following priority areas:

1. Strategies to facilitate the integration of services to result in improved health outcomes and greater efficiencies

2. Strategies to improve the performance of health workers (through strengthened supervision and increased motivation) to deliver quality services

3. Strategies for community engagement to increase awareness of, access to, and utilization of health services, and provision of appropriate services at the community level.

The proposed research should seek to adopt a systems perspective which may require a multi-disciplinary research team and the need to engage multiple stakeholders, including the women and men at whom the services are ultimately directed. In addition to ensuring a systems perspective, research-study supported through this call should incorporate the following considerations:

- Equity – the proposed research should consider the potential benefit and empowerment of vulnerable populations, particularly women and children.

- Innovation – the proposed research should respond to implementation issues not previously addressed by other research and strive to use new methods and approaches or apply existing methods in new ways.

- Capacity building – the proposed research study should provide opportunities to strengthen capacity for the conduct of research and use of evidence for the implementation and scale up of effective interventions. It should also ensure a gender balance in its capacity building activities.

The size of the budget for each grant should be based on the scope and focus of each research study appropriate for the setting the study will be carried out. The budget for the 2-year research study cannot exceed US\$ 350 000. Additional funding from other sources should be sought if the budget is anticipated to exceed this amount.

The deadline for submission of proposals is 15 September 2012.

OPTH – research job opportunity – Atlanta USA

A project is available in the Office of Prevention through Healthcare (OPTH) in the Office of the Associate Director for Policy (OADP) at the Centers for Disease Control and Prevention (CDC) in Atlanta, Georgia. Through partnerships and leveraging opportunities presented both inside and outside of the federal health system, OPTH develops strategy to further the linkages between public health and the broader healthcare system.

The Research Participation Program for CDC is administered by the Oak Ridge Institute for Science and Education (ORISE). The appointment is for one year and may be renewed upon recommendation of CDC and subject to availability of funds. The participant will receive a monthly stipend depending on educational level and experience. The participant must show proof of health insurance. The appointment is full-time at CDC in the Atlanta, Georgia, area. Participants do not become employees of CDC or the program administrator, and there are no fringe benefits paid.

Qualifications:

Masters of Public Health or similar relevant educational background required, with major study in an academic field related to the public health policy, is strongly preferred. Applicant must have received his/her degree within the last five years, or must expect to complete all requirements for such a degree prior to starting the fellowship. HEIDI : A new way of sharing and storing health information in the EU

In May, HEIDI – an internet based wiki that presents reliable and comparable data about health in the EU – was launched by the European Commission's Directorate-General for Health & Consumers. Although Heidi has been set up by the Commission, the content is written by European health experts – who are responsible for their contributions and can directly upload and edit information. HEIDI stands for Health in Europe: Information and Data Interface. It is a dynamic tool that collects, updates and shares information about health in Europe, for example on health status, health determinants, systems and policies. The abundance of health data and indicators in the HEIDI wiki is constantly being added to and updated. The data can be sorted per year, by country and by region, allowing at-a-glance comparisons across the years and between Member States and regions in the EU. For a selection of health topics, the tool allows for the data to be presented in a variety of graphs - line chart, bar chart, map chart and table chart.
