The Journal of Human Development and Capabilities (JHDC) is pleased to announce a call for papers for a special issue on Health and Disability. This call for papers aims to advance the state of knowledge and expertise regarding health, disability and human development, as well as the linkages among them and a range of policies, institutions, and social structures that influence such links and their dynamics.

Submissions related to this topic are welcome. In particular, though not exclusively, we welcome submissions in the following themes: i) Social justice and resource allocation; ii) Health system financing and access; iii) Public health and health policy; iv) Disability, poverty and human development; v) Social determinants of health and disability; vi) Disability definition and measurement; vii) HIV/AIDS and antiretroviral therapies; viii) Health care services and provision, and; ix) Maternal, child and reproductive health.

Full papers in English, in .doc or .docx formats should be submitted by November 30th, 2014. Strict compliance with this deadline is required. Papers submitted will be evaluated through a standard peer review process. Authors of the selected papers will be notified by e-mail.

In addition they must integrate all the technical guidance tools, supporting documents and templates to be used along the sequence of all possible interdependent and linked procedures and operations at every stage of the assessment process.

Access to healthcare for the most vulnerable in a Europe in social crisis

HEAL Press release: Health costs in the EU - How much is related to EDCs?

Brussels, 18 June 2014 – Exposure to food and everyday electronic, cosmetic and plastic products containing endocrine disrupting chemicals (EDCs) may be costing up to €31 billion per year in the EU, according to a [report](#) launched today by the HEAL.

Spiralling rates of hormone-related disease may be due to exposure to hormone-mimicking synthetic chemicals found in food, drink and everyday products.

- New study says if a small portion of hormone-related cancers, diabetes and obesity, and infertility could be avoided by reducing exposure to hormone disrupting chemicals, then billions in costs from these diseases and conditions could be saved.

- A change in European chemicals policy could massively reduce costs associated with cases of hormone-related diseases and conditions. EU should act now.

European Healthy Stadia Network: European Smoke-free Stadia Report Published

Only 10 European Football Nations Have Rigorous Smoke-Free Stadia Policies

European Healthy Stadia Network has recently completed the first phase of three year programme that is advocating for smoke-free football stadia across Europe. Part one of the programme has developed an up to date report detailing those European football nations who have stadia with a total or partial ban on smoking, and more importantly, those without any smoke-free policy at all.

This research has been funded by Healthy Stadia's partnership with World Heart Federation and UEFA's social responsibility department. CDC: Overprescribing causes prescription painkiller abuse

In 2012 health care providers wrote 259 million prescriptions for opioid painkillers — equaling a bottle of pills per American adult — according to data released by the Centers for Disease and Control and Prevention on Tuesday.

In this past decade, the number of prescriptions written have increased by 400 percent. With the surge in painkiller prescriptions, the U.S. has also seen an increase in deaths due to opioid and narcotic painkiller overdoses.

The agency reported the “overdose epidemic” in 2012, with increased death rates in several states from the late 1990s. In 2010 women had five times the number of prescription drug overdoses than they did in 1999. In 2011 prescription painkiller overdoses surpassed deaths from heroin and cocaine combined.

Patients with HIV, cancer less likely to receive oncology treatment

Among those with cancer, patients with HIV were less likely to receive cancer treatment than patients without HIV, according to data published in the *Journal of Clinical Oncology*.

The study included 3,045 patients with HIV and 1,087,648 patients without HIV. The most common cancers in the patients with HIV included diffuse large B-cell lymphoma (DLBCL), lung cancer and anal cancer, whereas in patients without HIV, the most common cancers were prostate, breast and lung cancers. For DLBCL, lung cancer, Hodgkin's lymphoma, prostate cancer and colorectal cancer, a significantly higher proportion of patients with HIV did not receive cancer treatment compared with patients without HIV. The associations for cervical and breast cancer were not significant and treatment for anal cancer was the same in both patients with and without HIV.

Among patients with HIV, predictors of a lack of cancer treatment included distant and unknown cancer stages, men with HIV exposure by IV drug use, age 45 to 64 years, black race and CD4 counts lower than or equal to the median of 144 cells/mcL.

Death by prescription painkiller

The number of deaths involving commonly prescribed painkillers is higher than the number of deaths by overdose from heroin and cocaine combined, according to McGill researchers. In a first-of-its-kind review of existing research, the McGill team has put the spotlight on a major public health problem: the dramatic increase in deaths due to prescribed painkillers, which were involved in more than 16,000 deaths in 2010 in the U.S. alone. Currently, the U.S and Canada rank #1 and #2 in per capita opioid consumption.

AJPH investigates public bike-share programs and head injuries

A recent study from APHA's *American Journal of Public Health* sheds new light on public bike-share programs. The study, which compared 10 cities in the United States and Canada with and without bike-share programs, found that cities with bicycle shares are correlated with an increased proportion of head injuries among bicycle-related injuries.

Appearing in cities from Washington, D.C., to Minneapolis, the public bike-share programs make bicycles available on a rental basis and increase options for access to physical activity within urban areas. The study found that in cities with bike-share programs, the proportion of head injuries among bicycle-related injuries increased from 42.3 percent before the programs began to 50.1 percent after. In comparison cities without sharing programs, the proportion of head injuries among bicycle-related injuries did not change significantly.

So what does all of this mean? According to the study, the majority of bike-share programs in North America do not provide helmets. While the study did not examine whether injured bicyclists were wearing helmets —or whether they were bike-share users at the time of their injuries — the researchers concluded the safety devices are important in sharing programs because of their ability to save lives. They called on programs to implement helmets in their planning and funding.

EC Scientific Committee on Emerging and Newly Identified Health Risks published final opinion on Nanosilver

On 13 June 2014, the European Commission and its non-food Scientific Committee on Emerging and Newly Identified Health Risks (SCENIHR) published the final opinion on Nanosilver: safety, health and environmental effects and role in antimicrobial resistance. SCENIHR concluded that the widespread (and increasing) use of silver containing products implicates that both consumers and the environment are exposed to new sources of silver. More data are needed to better understand bacterial response to ionic silver and silver nanoparticles exposure.

Study maps EU school food policies for the first time

As part of the European Commission's efforts to help reduce childhood obesity, the Commission's in-house science service, the Joint Research Centre (JRC), has published the first comprehensive report on school food policies in Europe. It shows that European countries acknowledge the important contribution of school food to children's health, development and performance at school. All the countries studied (28 European Member States + Norway and Switzerland) have guidelines for school food, although these vary considerably. National measures aimed at promoting healthy diets in schools range from voluntary guidelines, for example for menus and portion sizes, to complete bans, including on marketing, of vending machines and sugar-sweetened drinks.

New evidence-based tools to reduce health inequities in Europe

While health indicators have improved overall in the WHO European Region, this improvement is unevenly distributed within and between the 53 Member States and between population groups within them. As a result, avoidable inequalities are increasing in the Region. For example, the gap in life expectancy between the European countries with the highest and lowest is 17 years for men and 12 years for women. The 2008 economic crisis has exacerbated this trend, but appropriate policy intervention can reverse it.

The WHO Regional Office for Europe and the European Commission jointly carried out a project to produce policy guidelines and tools for addressing health inequalities. Its results provide policy-makers with evidence on how policies affect socially determined health inequities and guidance on what actions can be taken to improve health equity. The project has produced several tools for use in pursuing the two priority goals of the European policy framework, Health 2020: reducing health inequities and improving governance for health. They comprise interactive online atlases and a series of policy briefs.

Making the European Region free of asbestos-related diseases

Asbestos is one of the most severe and widespread environmental health hazards in the WHO European Region, and is responsible for half of fatal cancers linked to exposure at work. To discuss activities to put an end to asbestos-related diseases, representatives from 16 Member States in the WHO European Region and experts in occupational health and cancer registries met in Bonn, Germany, on 10–11 June 2014.

They evaluated progress made since the 2010 Parma Declaration and emphasized the need for WHO support to develop national programmes on asbestos elimination. The Parma Declaration commits governments in the European Region to take action on a range of environmental issues affecting health. This includes commitments to act on the identified risks of exposure to carcinogens, including asbestos, and to develop national programmes for the

elimination of asbestos-related diseases by 2015, in collaboration with WHO and the International Labour Organization (ILO).

Addressing the legacy of polio in Tajikistan

Most of the victims of the 2010 polio outbreak in Tajikistan were children, many of whom have developed physical impairments that require long-term rehabilitation care. In partnership with Ministry of Health, WHO initiated a disability rehabilitation programme to address the needs of this group, and in March 2014 with the technical support of the WHO Country Office, rehabilitation camps were organized to assess their current needs and develop appropriate intervention plans. Technical assistance was also provided to guide the country in strengthening appropriate service providers.

3 ministers join in call to action to promote healthy lifestyles for children in Turkey

Key findings of a major childhood obesity study conducted in Turkey and 20 other countries in the European Region in 2013 indicate that only approximately 7–8 out of 10 children in the country are within normal limits in terms of children's BMI Z-score values. Conversely 23.3% of boys and 21.6% of girls are overweight or obese, and 2.2% of boys and 1.9% of girls are thin or severely thin.

The study also found that fresh fruit is distributed in only 9.7% of Turkish schools in the study and fresh vegetables in only 8.3% of the schools. 66.2% of the schools perform healthy living activities and 63.4% offer sports activities for all students.

The third round of the European Childhood Obesity Surveillance Initiative (COSI) survey conducted with the support of WHO/Europe in Turkey reached 5101 students attending second grade in 216 schools located in 67 provinces across the country.
