### 3. Call for proposals, job opportunities

**Research for Health in Humanitarian Crises (R2HC) – Call for proposals** Enhancing Learning and Research for Humanitarian Assistance (ELRHA) is launching its new programme – **Research for Health in Humanitarian Crises (R2HC)** - at a series of regional townhall meetings in June and July 2013.

R2HC is a groundbreaking new collaboration between the UK Government's Department for International Development (DFID) and the Wellcome Trust that <u>will</u> support world class research into public health interventions in humanitarian disasters.

The aim of the programme is to strengthen the evidence base underpinning public health interventions in humanitarian contexts in order to improve health outcomes, enrich humanitarian practice, and facilitate closer collaboration between researchers and practitioners.

The first R2HC Call for Proposals will be officially opened in early June and launched through a series of townhall meetings around the world: London, UK – 5th June New York, USA – 12th June Delhi, India – *week commencing 8th July (date to be confirmed)* Nairobi, Kenya – 18th July These events will be most relevant for professionals in the public health research and humanitarian fields who may be interested in applying for research programme funding or seeking to build partnerships between researchers and practitioners.

# A Healthy Start - Second European Perinatal Health Report by the Euro-Peristat project

The Health and Care of Pregnant Women and Babies in Europe in 2010

The burden of mortality and morbidity in the perinatal period – pregnancy, childbirth, and the postpartum – remains a major concern in Europe. Over 5 million women deliver babies in European countries every year. A healthy pregnancy and infancy confers long-lasting benefits by preventing death and disability in childhood, and reducing risks of adult chronic diseases such as diabetes and hypertension.

The European Perinatal Health Report released by the EURO-PERISTAT project is the most comprehensive report on the health and care of pregnant women and babies in Europe and brings together data from 2010 from 26 European Union member states, plus Iceland, Norway

and Switzerland. EURO-PERISTAT takes a new approach to health reporting. Rather than simply comparing countries on single indicators such as infant mortality, our report paints a fuller picture by presenting data about mortality, low birthweight and preterm birth alongside data about health care and maternal characteristics that can affect the outcome of pregnancy. It also illustrates differences in the ways that data are collected and explains how these can affect comparisons between countries.

The first EURO-PERISTAT report, with data for 2004, was published in 2008. It found wide differences between the countries of Europe in indicators of perinatal health and care. Documenting these differences is important because it shows that gains are possible in most countries, provides information about alternative ways of providing care, and raises important questions about the effectiveness of national healthcare policies and the role of evidence in maternity care. This second report provides the opportunity to see whether these gains have been achieved and whether inequalities between the countries of Europe have narrowed.

The European Perinatal Health Report is a major feat of collaboration between researchers and official statisticians in Europe. It also contains data from two other European projects: Surveillance of Cerebral Palsy in Europe (SCPE) and European Surveillance of Congenital Anomalies (EUROCAT).

### WFPHA: Declaration on Access to Oral Health for Children

Passed by the WFPHA General Assembly - 2013

Every child has a right to good oral health. Oral health problems in children can impact on many aspects of their general health and development, causing substantial pain and disruption to their lives and often altering their behaviour. Oral health is an integral part of overall well-being and essential for eating, growth, speech, social development, learning capacity and quality of life.

To promote oral health every child should have access to:

- Oral health education including oral hygiene instructions and dietary advice, and access to affordable toothbrushes and toothpaste containing fluoride as soon as the first primary tooth erupts
- Preventive interventions, appropriate to the infrastructure and priorities of the country, which may include dental sealants, community fluoridation, and regular fluoride varnish applications
- Treatment of early stage decay to stop it from progressing to cavities, and treatment of dental cavities, acute pain and other oral diseases
- Environments that eliminate advertising of unhealthy foods to children.

Through good oral health all children will have an equal opportunity to thrive and reach their full potential for a promising future.

### Floods in the WHO European Region: health effects and their prevention

(Edited by Bettina Menne and Virginia Murray)

In 2009–2011, the WHO Regional Office for Europe and the United Kingdom Health Protection Agency undertook a project to investigate the adverse health effects of floods and to understand how best to protect the health of populations during floods in the WHO European Region. The project had two main components. A questionnaire was sent to 50 of the 53 Member States of the WHO European Region to collect information on recent experience of floods, their health effects and current preparedness and response mechanisms. In addition, a systematic review was undertaken of the epidemiological literature on the global impact of flooding on health. Analysis of the returned questionnaires and the peer-reviewed literature brought to light many issues pertinent to Europe. These findings will help WHO to prepare evidence-based guidance for the European Region on health concerns before, during and after flooding incidents and the measures for prevention, response and recovery.

# Health effects of particulate matter. Policy implications for countries in eastern Europe, Caucasus and central Asia

Despite some improvements, current levels of air pollution still pose a considerable risk to the environment and to human health in the WHO European Region. One issue of concern is that monitoring of particulate matter is very limited in the countries of Eastern Europe, the Caucasus and central Asia. This paper summarizes the evidence about the health effects of air pollution from particulate matter and presents the policy implications, the aim being to stimulate policy-makers to develop more effective strategies to reduce air pollution and its health effects in those countries.
