### **The Open Society Foundations on Austerity**

During the conference, the Open Society Public Health Program will present two sessions on the timely topic of austerity in Europe. The first is a roundtable discussion on Friday about austerity's impact on access to essential medicines and medical innovation, and the second is a workshop on Saturday about its effect on the health and rights of people who society largely excludes.

#### **Access to Medical Innovation in Times of Austerity: a right for all or a privilege for the wealthy?**

**Friday, November 15, 13:30 – Room 212**

This session examines the costs of medicines, growing access challenges, the underlying scientific, technological, economic model and its politics, and will ask whether—in an age of austerity—profit and patent-driven medical innovation are suited to ensure the health and rights of all people.

#### **Austerity, Social Exclusion and Health in Europe**

**Saturday, November 16, 9:00 – Room 215**

This session explores the politics of a fiscally weaker Europe and the health impacts of austerity on those people society has deemed politically undesirable or expendable—including migrants, people who use drugs, and sex workers. It proposes approaches that may protect the European social compact and access to health for all.

### Committee of the Regions

The Committee has been seized by the Commission to offer the views of the local and regional authorities on the recent report on health inequalities in the European Union [SWD(2013)328]. Health inequalities in the EU remain a reality. Although there is some progress in a few areas, the gap is still wide. People with lower education, a lower occupational class or lower income tend to die younger and have a higher incidence of most types of health problems. Likewise, infant mortality is higher in the lowest socio-economic groups.

The Committee of the Regions recognises the role of local and regional authorities in delivering health outcome and contributing to a more equitable distribution of health. The 2013 report on health inequalities is therefore of high importance to its members.

The rapporteurs on the opinion would be happy to meet with representatives of local and regional associations and other stakeholders for a consultation and an exchange of views on the relevant topic of this opinion.

The consultation will take place on Thursday 7 November 2013 between 11.00 a.m. and 1.00 p.m. in the Committee of the Regions building (Rue Belliard 99-101, B-1040 Brussels) Room JDE 70.

The rapporteur should welcome your views during the meeting. After a short introduction by the rapporteur, stakeholders will be invited to exchange views with the rapporteur.

In addition, if you have any position papers relevant to the subject, you are welcome to send them to us by e-mail using the addresses below.
