EPHA response to the Commission consultation on trade

EPHA considers that the EU Trade Policy should complement and reinforce all dimensions of the Europe 2020 Strategy, innovation but also the inclusive and sustainable dimensions. This means that the EU Trade Policy should be driven by social cohesion, and green objectives as well as by innovation.

In other words, trade (inside and outside the EU) should be welcomed and supported, but only in so far as it leads to better quality of life, including better health for all (inside AND outside the EU). Among other points, EPHA argues that :

1. From a public health perspective some barriers to trade should remain in order to allow developing countries to develop and sustain their internal markets and their societal development

2. The EU should not necessarily aim for more trade in services, and certainly it should not aim at opening trade in health-related services.

3. Any commitment to opening market access to services should include explicit exemptions in relation to legislation and administrative action designed to promote tobacco and alcohol control and prevent their harm.

4. EU trade policies should discourage the production and exchange of tobacco products in any way or form.

5. EU trade policies should not promote production and exchange of alcohol.

6. The EU should ensure that future Free Trade Agreements and Bilateral Investment Treaties (BIT) preserve sufficient regulatory autonomy for purposes of protecting public health.

7. The EU should consider the impact of trade on the universal provision of quality healthcare and education services and more particularly should follow the guidance and implement the WHO voluntary Code of Practice in International Recruitment of Health Workforce.

8. Any International Trade Agreements to include trade in services should consider labour and environmental standards that foster quality care and provision related to their enforcement.

9. The EU Trade Policy should go beyond GDP to measure its success and mainstream this approach in the negotiations with WTO and through any FTA.

10. EPHA also believes that the future Trade Policy which – although non-development focused – should assist developing countries` efforts in achieving the Millennium Development Goals (MDGs) and global efforts to eradicate poverty and hunger (as stated in the European Consensus on Development, 2006).

11. EPHA considers that protecting IPR is not necessarily the way forward from a public health point of view and health and health-serving "public goods" should be treated according to the 1994 WTO conclusion on TRIPs and recognition of policy space for developing countries to protect public health. Policy Brief on the current picture of public and private expenditure on long-term care for older people

This Policy Brief aims to present information, on the one hand, on the current picture of public and private expenditure on long-term care for older people and discuss the challenges of financing care. Available data from national and international sources as well as qualitative information gathered in the European Centre's recent publication "Facts and Figures on Long-term Care -- Europe and North America" is used to shed light on these issues. On the other hand – given that user payments for long-term care can be quite high as a percentage of an individual's income (especially for institutional care) – this Policy Brief provides preliminary results on potential redistribution effects of home care benefits (based on SHARE data). By that, the policy brief tries not only to take a policy-oriented, comparative view on funding arrangements for long-term care but also to serve as a starting point for further discussions on the potential inequalities associated with the different ways of financing and providing long-term care.

The European Patients' Forum welcomes new rules on Pharmacovigilance that will enable patients and health professionals to work more effectively together for improved medication safety Brussels, Belgium, September 22, 2010 - The European Parliament adopted today in a plenary session, a legislative proposal to strengthen the European pharmacovigilance system and reduce adverse effects of medicines. The proposal amends the existing EU framework on pharmacovigilance provided in Regulation (EC) No 726/2004 and Directive 2001/83/EC. The new legislation is expected to enter into force by the end of 2010 or early 2011, and must be put into effect in Member States within 18 months of its publication in the EU Official Journal.

The European Patients' Forum (EPF) welcomes the new legislation, which will strengthen the pharmacovigilance system and make it more transparent, enhancing the confidence of patients, health professionals and regulators in the system. The EU Eudravigilance database will be the single repository of adverse reaction reports, and will be made accessible for patients and the general public. The new framework also strengthens patients' involvement, including provisions for direct patient reporting of suspected adverse reactions.

EPF particularly welcomes the possibility for patients to report suspected adverse events directly to national competent bodies. Patients have a unique knowledge and experience of the effects of the medicinal products they take, which should be used more effectively. EPF last week organised a seminar on the topic at the European Parliament, jointly with PGEU, the Pharmaceutical Group of the European Union, to highlight the importance collaboration between patients and pharmacists in medicines safety. The event was sponsored by Mrs Linda McAvan MEP, the Rapporteur on the legislative proposal, whose contribution was invaluable in ensuring the new rules take into account the views of the patient community.

Responding to the new legislative proposal, EPF President Anders Olauson says that "direct patient reporting and a wider access to safety data are necessary as they contribute to patients' empowerment and greater patient safety. These efforts should be seen as integral to the wider EU debate on patient empowerment and health literacy, with the aim of enhancing the safety and quality of care for all patients across the European Union."

Evidence of huge boost to public health from stronger climate policy

Brussels, 6 September 2010 - A report to be launched next Tuesday, 14 September 2010 analyses the health benefits for Europeans of stronger EU action on climate change, and reframes the current discussions from climate costs to climate benefits, particularly for people's health and healthcare systems. Published by Health and Environment Alliance (HEAL) and Health Care Without Harm Europe (HCWH E), it quantifies some of the very substantial health and economic benefits of moving to a 30% target on reductions in greenhouse gas emissions.

The report provides figures on overall public health benefits in the European Union from a tightening on climate change policy and the first-ever figures on health benefits for individual EU Member States of the 30% target. The report also demonstrates that the sooner the European Union moves to the higher target, the better for health, health care budgets and productivity.

"This report makes the case and provides new evidence for EU and Member State politicians and policy makers to support the move to a 30% domestic target on greenhouse gas emissions," says Dr Pendo Maro, Senior Climate and Energy Advisor, Health Care Without Harm (HCWH) and Health and Environment Alliance (HEAL).

European report on preventing violence and knife crime among young people

Interpersonal violence is the third leading cause of death and a leading cause of disability among young people (those aged 10-29 years) in the 53 countries in the WHO European Region. This report describes the burden that violence imposes on the Region, particularly its poorer countries and groups; risk factors and their interactions; factors that can protect young people from violence; and the evidence supporting the efficacy of preventive action. The report concludes by calling for greater investment in prevention and mainstreaming of the objective of preventing violence among young people into other areas of health and social policy.

Policies and incentives for promoting innovation in antibiotic research

(By Elias Mossialos, Chantal M. Morel, Suzanne Edwards, Julia Berenson, Marin Gemmill-Toyama and David Brogan).

High levels of pathogen resistance are rendering current antibiotics obsolete. Coupled with insufficient investment in discovering new treatments, multidrug-resistant infections are an increasingly urgent public health concern.

To curb the growth of antibiotic resistance and prevent major morbidity and mortality from multidrugresistant bacterial infections, the overuse of antibiotics must be addressed and research and development for antibiotics with novel mechanisms of action actively promoted. This requires appropriately designed incentives for health and regulatory systems, in addition to economic incentives to attract academic interest and industry investment.

This book, commissioned by the Swedish Government from the European Observatory on Health Systems and Policies, analyses many proposed policies and incentive mechanisms and sheds light on the key issues that will help policy-makers reach informed, concrete decisions on how to avert this potential public health crisis.
