The importance of public health in 2026

The start of 2025 marks a decisive moment for public health in Europe. In a changing geopolitical and societal landscape, from misinformation and democratic fatigue to climate disruption and persistent inequalities, the public health voice must remain strong, science-based, and united.

EUPHA continues to provide independent, evidence-based advice to decision-makers and to advocate for policies that protect and promote health for every person in Europe. We place special focus on mental health, health equity, and systems resilience, while promoting cross-sectoral approaches that connect climate, digitalisation, and social justice.

Our work demonstrates that public health is not only a technical field but also a democratic one: protecting evidence, participation, and trust is vital for Europe's future.

About EUPHA

EUPHA envisions itself as a dynamic and innovative knowledge hub, acting as an interface and platform for its members, the EU, and the WHO. EUPHA aims to provide substantial value to our members through the dissemination of critical information and support for capacity-building efforts. Our strategic direction is to ensure coherence in all our objectives, from sense-making to graphic representation and governance, thereby giving clear meaning and purpose to our actions.

Our mission

For Europeans to achieve the highest possible level of health, we work on providing independent and authoritative analysis of the evidence, combined with targeted advocacy to achieve coordinated action by all key stakeholders.

Our method

A member-based association with transparent and shared governance...

EUPHA as a member-based association works in collaboration with the National Public Health Associations across Europe. This work allows us to bring together a robust community of Public Health Actors. EUPHA ensures coherence in all objectives, from sense-making to transparent governance, thereby giving clear meaning and purpose to our actions.

The vision and the values of Public Health are the guide for the Office team and all the structure.

...reaching out to Communities across Europe...

Inspired by our vision to achieve a better health and well-being for all in the european region and to narrow health inequalities for all Europeans, we actively work at developing social participation and community engagement in Public Health across Europe, as it has proven to:

• Enhance the relevance and effectiveness of public health policies.

- Empower communities, leading to greater health equity and better health outcomes.
- Build trust between the public and health authorities, which is crucial for response in public health emergencies, a better resilience of the health system and social cohesion

Our members are themselves close to the people and European Population, and our sections work with people with lived experience as patients. Hence, EUPHA is able to reach out to communities and have a substantial impact at population level through our members and sections.

- We encourage the development of interventional and participatory research and citizen science supported by a coordinated effort of our established sections including the Health Promotion Section and Health Service Research Sections. In this regard, as a science-based organisation, our first goal is to engage citizens through our main activities.
- Our new field of work with local governments through the partnership with WHO Healthy Cities brings us closer to act at the local level upon social, ecological, commercial determinants who are the main cause of NCDs and burden of disease in Europe leading to significant costs in the health system.
- Our capacity building activities ranging from Spring, Summer and Winter Schools has proven to be an outcome that allows to reach to a wide spectrum of public health professionals including community health workers, an emerging profession that needs institutionally recognized training to increase recognition, who are the outreach arm acting directly with and for populations in particular vulnerable groups. We will work in collaboration with ASPHER to develop, in line with the competency framework, a new accreditation proposition to empower and develop professional competencies and recognition of those actors.

We are working on making EPH conferences more accessible to diverse populations and health workforce to include community health workers and people with lived experience through:

- → Partnering with our sections to showcase community engagement.
- → Organising pre-conferences on topics of co-creation and community participation.
- → Inviting individuals with lived experiences to participate in the main conference, particularly through the Mental Health Section.
- → Providing economic support for patients and community representatives to make the attendance costs affordable
- → Implementing new scoring strategies for abstracts to reflect inclusion and incorporate community perspectives.
- → Offering conferences open to the local population and the public.
- → Hosting satellite events with civil society and local public health practitioners to raise awareness, empower communities, and promote local/national best practices.

... fostering Inclusivity.

We aim to create an environment that allows meaningful participation from marginalised and vulnerable groups, overcoming barriers such as language, literacy, and technological access.

From Triple A to the 4Es: a new strategic cycle

Since 2020, EUPHA's Triple A approach — **Analysis, Advocacy, Action** — has positioned us as Europe's collective voice for evidence-based public health. Building on this success, the 2025–2030 Strategy was co-created through surveys, webinars, and a strategic retreat with our members and partners.

Our guiding principles: the 4Es

Evidence – Generate, curate, and translate public health science for policy impact.

Equity – Narrow health inequalities and promote Health in All Policies.

Empowerment – Build competencies and recognition for the public health workforce through EUPHAcademy and partners such as ASPHER and WHO.

Engagement – Foster collaboration across disciplines, sectors, and communities to strengthen social participation and trust.

Our strategic objectives

Strengthen and connect science within and between disciplines (creating synergies across Sections and projects).

Empower policymakers and stakeholders to translate evidence into decisions (through advocacy, training, and dialogue).

Build capacity for the public health workforce, expanding accreditation, micro-credentials, and career pathways.

Engage society by strengthening EUPHW, citizen science, and community participation.

The Executive bodies




Figure 1: EUPHA general governance

<u>Executive Council</u>: Charged with the management of the association, composed of prominent public health experts in Europe, including the EUPHA president, past president, president-elect, treasurer, secretary, EJPH editor-in-chief, Section Council chair, and EUPHAnxt coordinator.

<u>Governing Board, representing the Members</u>: The highest authoritative body in EUPHA, comprising delegates appointed by the members of each country. Institutional members have a non-voting seat. *See members below.*

<u>EJPH Council</u>: Coordinates the general policy for the European Journal of Public Health (EJPH) and EUPHA's activities related to the Journal.

<u>Section Council</u>: Represents the interests and common concerns of all EUPHA sections, facilitates relations between sections and other relevant bodies, and makes recommendations to the annual European Public Health conference programme.

<u>EUPHAnxt Team</u>: The EUPHAnxt team supports the activities of EUPHA. EUPHAnxt is EUPHA's network for students and early career researchers, policymakers and professionals in the field of Public health. It gathers around 4000 professionals across Europe.

The Office

The EUPHA office is responsible for the day-to-day running of EUPHA. EUPHA office has weekly meetings to discuss all issues of the work plan, to execute the concrete operational framework and for upcoming questions and new initiatives. Related to the activities included in the operating grant, the EUPHA office team consists of the Executive director, the Chief Finance and Administration officer, the Communication officer, the Network coordinator, the Policy officer and the Office manager.

79% of the office is dedicated to EUPHA's activities on the grant, the rest of the time being dedicated to the EPH Conference Foundation.

Thanks to the Operating Grant 2024-2025, and with confidence as EUPHA scored a 97/100 for the FPA 2025-2026, we were able to recruit several new people to work in EUPHA.

The Members

EUPHA is an international, scientific organisation, bringing together around 35,000 public health experts for professional exchange and collaboration throughout Europe.

EUPHA now (October 2025) has 72 members from 36 countries, including members from all EU Member States. Our members include:

- 41 national associations of public health
- 31 institutional members




Figure 2: Map of EUPHA members

EUPHA has 29 operational sections on a wide range of public health topics, supported financially and organisationally by the EUPHA office. The presidents of the sections are renowned experts in their fields, supported in subject expertise by vice-presidents and steering groups.

European Public Health Week (EUPHW) - 7th Edition

12th - 16th May 2025 | 'Innovation for Resilience: Shaping a Sustainable Future'



The EUPHW aims to connect those who contribute to better public health across the WHO European Region, to promote collaboration among the public health community, and to boost EUPHA's profile and visibility. The theme and overall purpose of this annual initiative is to join forces for healthier populations.

The 2025 edition of European Public Health Week (EUPHW) continued to build momentum as a pan-European communications campaign, raising awareness of critical public health topics, amplifying trusted messages, and strengthening connections across Europe's public health ecosystem. Held from 12–16 May 2025, the campaign was coordinated by the European Public Health Association (EUPHA) and co-funded by the EU4Health programme.

This year's overarching theme "Innovation for Resilience: Shaping a Sustainable Future" reflected a timely focus on how innovation, collaboration, and

forward-looking strategies are central to building more equitable and robust health systems.

Goals of EUPHW 2025

EUPHW 2025 set out to:

- Highlight the role of public health in driving innovation and systems resilience;
- Build trust and public understanding around health challenges and solutions;

- Foster collaboration across disciplines, sectors, and borders;
- Support inclusion by amplifying youth voices and reaching communities across Europe.

As every year, the seventh European Public Health Week (EUPHW) was actively supported by the WHO Regional Office for Europe, the European Observatory for Health Systems and Policies, and the European Commission. Each day of the week focused on a specific public health theme.

Each weekday focused on a distinct theme, addressing topics such as planetary health, systems change, the life course, and the next generation of public health leaders. The daily themes were developed collaboratively with input from the Steering Committee, EUPHA Sections, and key partners, including WHO Regional Office for Europe, EuroHealthNet, and Mental Health Europe.

Planning and coordination

Key messages

- 1. Innovation drives resilience Public health must embrace innovation to build stronger, more sustainable systems.
- 2. Collaboration strengthens impact EUPHW fosters cross-sector dialogue and engagement at all levels.
- 3. Public health is about people and equity Achieving better health outcomes requires inclusive policies and community-driven solutions.
- 4. Knowledge leads to action EUPHW is a platform for sharing best practices, scientific insights, and practical solutions.
- 5. EUPHW belongs to everyone This is your event, empowering individuals and organizations across Europe to raise awareness, share knowledge, and drive change in public health.

Standout events and activities

A high-level launch event at the European Parliament

With a Brussels representation, the EUPHW had a special focus in connecting with EU policy makers.

For the first time, European Public Health Week 2025 was launched at the European Parliament on 12 May with a high-level hybrid event live from the European Parliament in Brussels. Under the theme Innovation for Resilience: Shaping a Sustainable Future, the session brings together public health leaders, EU policymakers, and on-the-ground professionals to explore how innovation can drive sustainable, resilient health systems in Europe and beyond.

Co-moderated by Charlotte Marchandise, Executive Director of EUPHA, and Dr Dheepa Rajan, Senior Advisor at the European Observatory on Health Systems and Policies, the launch event features a distinguished panel of speakers:

- Dr Raed Arafat, Secretary of State of Romania and Chair of NATO's Joint Health Group
- Dr Hans Kluge, Regional Director for WHO Europe
- Lorena Boix Alonso, Deputy Director-General, DG SANTE, European Commission
- ❖ MEP Nicu Stefănută, Vice-President of the European Parliament
- Laurent Muschel, Director, DG HERA, European Commission
- Dr Pamela Rendi-Wagner, Director, European Centre for Disease Prevention and Control (ECDC)
- ❖ The session featured powerful civilian perspectives from Ukraine and Romania, offering real-life insights into public health innovation in times of crisis:
- Yuliia Ovchar (Ukraine) on maintaining healthcare services amid conflict
- Irina Mateescu (Romania) on lessons from past public health emergencies

The event concluded with closing remarks from Tit Albreht, EUPHA President, highlighting key takeaways and the road ahead for public health in Europe.



The two-day BrailleRap Hackathon in Brussels

This inclusive innovation event exemplified the week's theme—Innovation for Resilience— by challenging participants to adapt 3D printing technology to improve accessibility for visually impaired communities. Taking a collaborative approach, the hackathon promoted open-source health tech, inclusion, and cross-disciplinary collaboration. It attracted engineers, students, and advocates working together to develop practical, replicable solutions to real-world challenges. The hackathon concluded with the donation of three fully-functional Braille embossers to Ligue Braille.



Building an Advocacy Toolkit for Science Policy

This interactive workshop equipped young professionals with practical advocacy skills to shape health policy. Participants learned how to craft evidence-based messages, tailor communication for different stakeholders, use public speaking to present public health issues effectively, and harness social media for digital advocacy. The event offered a hands-on platform to connect, learn, and take the first steps in influencing real-world change - embodying the day's focus on preparing the next generation of public health leaders.



Daily webinars

Each morning (Monday to Thursday), a live kick-off webinar opened the day with expert speakers, case studies, and examples from across Europe. These events attracted diverse audiences and provided a space for reflection, exchange and community-building.


Webinar recordings were made available online, ensuring access for those unable to attend live.

Participation and reach

This year's campaign marked another year of growth and momentum:

- 298 events held
- 21 participating countries
- Events delivered in 14 languages
- Formats included: 183 in-person events, 103 online events and 12 hybrid events

Most events were locally organized (216 events) and tailored, illustrating EUPHW's grassroots strength and its ability to connect European-level messaging to real-world public health contexts.

EPH Conference - 18th Edition

12th - 14th November 2025 | 'Investing for sustainable health and well-being'

EPH Conference is a foundation at the initiative of EUPHA, in charge of the organisation of the conference each year.

EUPHA provides a significant contribution to the scientific programme of the yearly EPH conferences. We do this together with a large number of European and international organisations and non-state actors.

Delegates

For the second time in the history of EUPHA/EPH conferences, we had to close the registration of delegates before the start of the conference. With 2900 delegates, we have reached the maximum number of delegates allowed by the Helsinki conference venue. Due to fire and safety regulations, we are not allowed to admit more people.

Almost 330 of our delegates have registered as students or trainees, and 290 delegates are coming from the host country, Finland.

Abstracts

Similar to the record-breaking year of 2024, the EPH Conference has once again received a high number of single abstract and workshop submissions. **3.294** abstracts of which **291** for workshops were received in total. 188 members of the International Scientific Committee from 35 countries reviewed the abstracts. The average score for single abstracts was **4,578** on a scale 1 to 7 (Lisbon 2024 - 4,442), the average score for workshops was **5,071** (Lisbon 2024 - 4,913). Single abstracts were scored by an average of **4,87** reviewers (Lisbon 2024 - 4,45), workshops by **4,88** reviewers (Lisbon 2024 - 4,69).

Based on the tracks and available rooms, the EPH Conference offered 176 session timeslots. It was decided to continue with PechaKucha tracks successfully introduced for the Lisbon 2024 Conference. It was decided to accept:

- 5 invitational workshops
- 117 high scoring workshops
- 141 single abstracts for 28 oral sessions
- 203 single abstracts for 26 pitch sessions
- 333 single abstracts for poster walks
- 1300 single abstracts for poster display
- ❖ 40 extra workshops just below cut off point for 2 PechaKucha tracks

European Journal of Public Health - EJPH

The European Journal of Public Health (EJPH) is a fully Open Access multidisciplinary journal in the field of public health, publishing contributions from social medicine, epidemiology, health services research, management, ethics and law, health economics, social sciences, and environmental health. It aims to strengthen the scientific and independent voice in public health and health services.

The EJPH is published bimonthly and each issue (6 per year) includes a 'European public health news' section, which includes columns from the EUPHA president, EUPHA office, WHO Europe Regional Director, and Health Commissioner of the European Commission. The journal provides a forum for discussion and debate of current international public health issues with a focus on the European region.

The journal is part of the Committee on Publication Ethics (COPE).

In addition to the regular issues, the journal also publishes supplements and e-collections, which allow for deep insights in specific public health topics.

The **supplements** are collections of five to fifteen papers, including an editorial written by the guest editor, and is particularly useful to analyze a topical public health issue.

In 2025, three supplements were published:

- Perspectives and Future Directions on the Prevention and Control of Vector-Borne and Zoonotic Diseases in the WHO Eastern Mediterranean Region
- Enhancing Public Health Leadership, Part A

Piloting HealthData@EU – The European Health Data Space

The **e-collections** are selections of 8-15 papers published during the past years in the EJPH, accompanied by a newly written editorial. The e-collections specifically target policymakers, summing evidence and recent findings on a debated topic.

In 2025, one e-collection was published on Youth Mental Health.

Brief statistics on manuscripts

The number of original manuscripts received is still increasing after the dip of submissions in 2022-23, while the proportion of accepted manuscripts has decreased. The last years' strong variations are most probably due to both the COVID-19 pandemic and transition to open access. The impact factor dropped to 3,7 last year, as in many other journals, again probably due to the COVID years, but has now increased to 3,9, better than some benchmarking journals. Moreover, the EJPH is in the top 25% of journals (Q1, SJR).

In the four issues published in 2025, 109 original manuscripts, 6 editorials, 5 viewpoints, and 2 book reviews were published. Each of the four issues also had a section with European public health news from EUPHA and partner organizations.

In 2025, manuscripts have been submitted from 71 countries across all continents. The highest number of submissions were received from China (158), the United Kingdom (48), Finland (38), Spain (36), Italy (34), Sweden (31), France (27), Germany (25) and the Netherland (20).

The highest number of accepted papers originated from the United Kingdom (22), Sweden (20), Finland (17), the Netherlands (15), Spain (14), Italy (14), Germany (11) and Franxe (9).

Average number of days from submission to first decision increased from 24.8 to 28.4 days, whereas the time from submission to final decision decreased from 29.4 to 16.2 days.

❖ Fellowship programme

The EPH Conference Fellowship Programme, launched in 2018 by EUPHA and EUPHAnxt, continues to offer students and young professionals an active role in the European Public Health Conference. In 2025, EUPHAnxt received 78 applications from Europe and beyond, with gender balance again favouring women. Six fellows were selected to collaborate with the EUPHAnxt and EPH Conference teams, contributing to communication and dissemination activities across multiple platforms. Their responsibilities included conducting short video interviews with EUPHA Section Presidents and Vice-Presidents, and producing social media content highlighting daily key takeaways on Instagram and LinkedIn. Fellows also participated in mentoring sessions with senior public health experts and attended both plenary and selected parallel sessions relevant to EUPHA's thematic areas. A new element introduced was the collection of post-conference written testimonials from each fellow, summarising the highlights of their fellowship experience and providing a reflective closure to the programme.

Abstract tutoring programme

The Abstract Tutoring Programme offers young and less experienced researchers the opportunity to receive feedback on their abstracts from experienced reviewers, particularly supporting those with limited access to academic mentorship or for whom English is not a first language. Administered by the EUPHA Office and promoted through EUPHAnxt's communication channels, the 2025 edition was open from 1 February to 9 April, aligning with the EPH Conference abstract submission deadline. Activities included updates to the tutor guidelines, recruitment of reviewers through EUPHA Sections, and active promotion via newsletters and social media. In 2025, 17 abstracts were reviewed by 13 reviewers, of which 13 were submitted and 11 accepted (85%) maintaining a high success rate comparable to previous years (last year, 21 abstracts were reviewed but only 10 were accepted 67%). Feedback indicated that reviewers were engaged and provided constructive input. For future editions, improvements will focus on enhancing the visibility of the programme, including earlier and more frequent promotion, and on strengthening reviewer engagement by informing Section Presidents and Vice-Presidents during the February coordination meeting.

Mentoring programme 2024-2025 (Second Edition)

The second edition of the EUPHAnxt Mentoring Programme (autumn 2024 – spring 2025) built upon the success of the inaugural round, offering tailored mentoring opportunities for early-career public health professionals across Europe. This edition included 16 mentees from 10 countries, matched with 10 mentors across 8 thematic areas, drawn from the EUPHA network, including the Section Council, Executive Council, and Governing Board. Mentoring took place either individually or in small groups of up to two mentees per mentor, enabling a higher mentor-to-mentee ratio and reducing dropout rates. The programme was launched with an online event in autumn 2024, followed by an informal in-person meeting during the EPH Conference 2024, fostering stronger connections between mentors and mentees. Feedback has been highly positive, with several participants expressing interest in maintaining collaboration beyond the formal programme. Furthermore, mentors and mentees jointly contributed to the 18th European Public Health Conference 2025 in Helsinki, co-organising a workshop that received an evaluation score of 5.8/7. To increase visibility and share experiences, five blog posts authored by mentors and mentees were published through EUPHA's

communication channels. Based on the evaluation of this edition, the third edition of the programme is already being organised, with its launch planned for October 2025.

Youth Advisory Hub

EUPHAnxt launched in July the Youth Advisory Hub. The hub is established to strengthen youth and early-career professionals engagement within EUPHA. Its primary purpose is to ensure closer alignment of EUPHAnxt activities with the priorities of the EUPHA Sections.

The Youth Advisory Hub will:

- Provide strategic guidance to EUPHAnxt activities from a youth perspective;
- ❖ Facilitate stronger connections between EUPHA Sections and EUPHAnxt;
- Serve as a platform for students, young professionals, and early-career public health experts to contribute to EUPHA's mission;
- Promote inclusivity, innovation, and youth engagement across EUPHA initiatives.
- Ensure governance sustainability and accountability within EUPHAnxt Core Group

Each Section was invited to nominate one youth representative to serve as a member of the Hub. Until now, twenty EUPHA Sections nominated one representative. Representatives are students, young professionals, or early-career experts (preferably under 35, but not mandatory).

Three seats will be allocated to students, young professionals, and early-career public health professionals based on applications submitted to the EUPHAnxt team to ensure diversity and inclusion.

The kick-off meeting took place on October 10 online and will be followed by another in-person meeting during the conference.

Sections Activities

In order for EUPHA to be able to provide the evidence in a wide array of topics, EUPHA is using thematic networks called EUPHA sections. The latter continued to be extremely active, giving EUPHA visibility all year round. It is therefore essential that EUPHA sections are supported in all their activities.

The sections continue to have a large interest with numbers of section members rising for all sections.

EUPHA as a partner in European projects

In 2025, EUPHA was involved in several European projects and was approached by numerous institutions and universities to join future consortia. This continuous engagement in European projects remains a cornerstone of EUPHA's strategy for financial resilience, partner engagement, and long-term impact. Below is an overview of our current projects and those completed in the past year.

HealthData@EU - link here

The HealthData@EU Pilot project was funded through the EU4Health Programme. It aimed to set up concrete foundations for the future so-called European Health Data Space for the secondary use of health data. In December 2024, the second and final year of the project was completed. EUPHA contributed to the



dissemination and communication activities, especially the coordination of the supplement to the <u>European Journal of Public Health</u>, which was published in 2025.

EARLY (Evaluating, Identifying and Reducing determinants of MHCs in Youth) - link here



The EARLY project aims to reduce youth mental health conditions (MHC),

including depression, anxiety, stress, and substance use disorders, by identifying and mitigating modifiable risk factors. It will develop a flexible exposure matrix for emerging risks, conduct interviews to understand youth and stakeholder perceptions, and gather multinational data on youth MHC. Using both qualitative and quantitative methods, EARLY will review mental health measures, analyze exposure data across demographics, and conduct focus groups and a cross-sectional survey in five

countries as the basis for a multicomponent intervention. Key outcomes will include a youth mental health model, an exposure matrix, actionable insights, accessible data, and strategies to reduce MHC risks in adolescence. In 2025, EUPHA contributed to EARLY's communication and dissemination efforts through a European Public Health Week webinar, an EPH Conference roundtable, and support for study recruitment activities.

PROPHET – link here

The PROPHET Project is one of the two projects that kicked-off in 2022. It is funded from the Horizon Europe Programme. The project aims to engage organisations and individuals to contribute to the construction of a Strategic Research Innovation Agenda



(SRIA) and Roadmap to adopt Personalised Prevention approaches into EU health systems. Until now, EUPHA contributed to various communication and dissemination tasks within the project and organised events during the EPH conference, which led up to EUPHA's stronger engagement in policy deliverables in Q4 2025 and in the upcoming 2026.

RIVER-EU (Reducing barriers to vaccine uptake in underserved communities) - link here

The RIVER-EU project ("Reducing Inequalities in Vaccine uptake in the European Region – Engaging Underserved communities") is a 5-year (2021-2026) project coordinated by the University Medical Center Groningen (UMCG) and funded by the Horizon 2020 Research Programme. Using an interdisciplinary approach, RIVER-EU will collect evidence on health system determinants of high and low vaccine uptake in eight specific contexts, which



will be used to identify and/or develop interventions to reduce barriers to vaccine uptake in underserved communities and increase trust in the health system. EUPHA's continuous engagement via consortium meetings during EPH conference and an engagement during the European Public Health Week build the foundation for EUPHA's policy & communication activities in this project finalising in 2026.

EuroHeartPath - link here

The EuroHeartPath project (2025-2030) aims to transform cardiovascular care in Europe by improving the entire care pathway—from early detection to prevention—for four key conditions: heart failure, atrial fibrillation, ventricular fibrillation, and coronary disease. The project will map current practices in 45 hospitals across 15 countries and conduct 18 pathfinder



studies to test the integration of innovations such as AI, digital tools, point-of-care testing, and robotics. By involving patients, cardiologists, and family doctors, EuroHeartPath ensures that solutions are practical and meet real needs. The ultimate goal is to identify and promote best practices that can improve outcomes for patients and strengthen health systems. From Q4 2025 onwards, under leadership of the EUPHA Chronic Diseases Section, EUPHA supports improvements in care delivery by sharing best practices across countries. EUPHA will be helping to ensure patient data is used ethically and safely, and contributing to the planning of how the project's results can be sustained and used in the long term.

Dissemination

EUPHA website

In 2025, EUPHA completed a full redesign of its website to better serve its growing and diverse audience. Guided by the EUPHA 2025–2030 strategy, updated brand identity, and a new tone and style guide, the redesign shifts from an organisation-led to an audience-led structure.

Key improvements include:

- ❖ A cleaner, modern visual identity reflecting EUPHA's mission and values.
- Plain language content to improve accessibility and understanding.
- A new section for learning and capacity-building resources.
- A fully responsive, mobile-friendly design.
- Improved SEO and integrated analytics to strengthen engagement.
- Enhanced accessibility meeting WCAG 2.1 standards.

The EUPHA newsletter aims to build the knowledge of public health professionals worldwide and to increase the visibility of EUPHA as an association that builds capacity, knowledge and policy in the field of public health, with an emphasis on the European Region. With over 37,700 subscribers (2024: 32,000) from 175 countries worldwide, the newsletter continues to be one of the most visible and highly appreciated tools of EUPHA. 85% of our subscribers come from Europe.

EUPHANxt and EUPHA's 29 Sections have their own dedicated newsletters.

EUPHA Rapid Response Team (RRT)

In order to be able to provide the evidence-base on a large number of public health topics in a short period of time, EUPHA created the Rapid Response Team in 2019. This network of 40 public health experts, mainly linked to the EUPHA sections, can be contacted when a journalist or a policymaker needs to get an answer on a question related to a certain topic. The RRT then provides the evidence-based information within 48 hours.

In 2025 EUPHA was contacted on 9 occasions in which the RRT was activated.



The visibility of EUPHA as a solid partner with a research background has been strengthened. EUPHA continues to build the capacity and knowledge of policy-oriented organisations and has an official seat in numerous Committees, Advisory groups and Councils.

Memorandum of Understanding

Sustainable advancements in public health and health services can only be achieved through collaboration. Currently, we have formal collaborative agreements and official status as a relevant stakeholder with several European and international intergovernmental and non-governmental organisations, including ECDC, HERA, EMA, and WHO-Euro, and the European Observatory on Health Systems and Policies. We also work with civil society organisations such as EuroHealthNet, the European Public Health Alliance (EPHA), and the European Health Management Association (EHMA).

We are enhancing our collaboration with the Association of Schools of Public Health in the European Region (ASPHER) to create a more powerful, trained, recognized and efficient Public Health workforce in Europe. We aim at integrating our policy responses, amplifying advocacy and facilitate Public Health workers careers by:

- Making our tools interoperable for our communities
- Working together on the Roadmap to professionalisation
- Working on a European Public Health Fellowship

The Executive Council has decided that the membership of Russian associations and organizations will be suspended until the Executive Council is of the opinion that the situation in Ukraine has sufficiently improved.
