ESCD in brief

The EUPHA section on Chronic Diseases (ESCD) was formally established at the 14th EUPHA annual conference in Montreux, Switzerland in 2006 and currently has 1004 members. The **aim** of the section is to increase and spread knowledge on chronic disease control and management. The section seeks to identify common approaches to develop the evidence and information base needed to guide policy and identify best practices for combating chronic diseases, and thus contributing to a sustainable and significant reduction of illness, disability and premature death. Furthermore, the section aims to lead efforts that help eliminate health disparities and negative socioeconomic consequences caused by chronic diseases and that promote health and well-being.

2. Pre-conferences / Workshops during the EPH conference 2013 in Brussels

Preconference

- At the 6th EPH in Brussels a preconference was organized by the ESCD together with the EUPHA sections on Child and Adolescent Public Health, Ethics in Public Health, and the EUPHaxnt. The objectives of the preconference *'Public Health: the Next Step'* was to discuss the thresholds that cause the stagnation of implementation of knowledge into practice and to discuss the value public health research wants to add to society today and the next decades.
- David Stuckler's (ESCD vice-president) speech entitled '*The Body Economic: Why Austerity Kills*', presented shocking and counterintuitive revelations and bold policy recommendations, that present an alternative to austerity—one that will prevent widespread suffering, both now and in the future.
- Approximately 34 participants attended the workshop.

Workshop: Pampers or pamper? Should we celebrate an ageing population or fear it?

- Organizers: Workshop organized by EUPHA together with the EUPHA sections on Chronic Diseases, Injury Prevention and Safety Promotion, Health Services Research, Health Promotion, Ethics in Public Health and Public Health Monitoring and Reporting.

- The workshop discussed the challenges and opportunities of ageing populations in Europe within the context of current economic crisis.
- Approximately 105 participants attended the workshop.

Workshop: An Optimal European Chronic Care Framework: Towards Implementation and Benchmarking

- Organizers: Epposi European Platform for Patients Organisations, Science and Industry; and the EUPHA Section on Chronic Diseases
- This workshop outlined key learning and policy recommendations to the practical implementation of Chronic Care Models (CCM) in Europe.
- Approximately 25 participants attended the workshop.

3. 1st V4 conference on Public Health

- The EUPHA and the ESCD joined the 1st Public Health conference of Visegrad Four (V4) countries Czech Republic, Hungary, Poland and Slovakia
- About 120 representatives from the V4 countries came together to discuss the subject at an international conference in Košice, Slovakia on 9–10 May 2013. The main aim of the event was to support further development of public health systems in the V4 countries and to foster multidimensional approach in ensuring healthy life years.

EUPHA statement for the Ashgabat WHO conference on NCDs

- ESCD members have prepared a statement for the WHO European Ministerial Conference on the Prevention and Control of Noncommunicable Diseases in the context of Health 2020 that took place on 3-4 December 2013 in Ashgabat, Turkmenistan. The process was lead by Dr David Stuckler, section vice-president and the new EUPHA policy pillar lead in collaboration with Dr Iveta Rajnicova-Nagyova, section president.
- ESCD contributed also to the joint NGO statement for the above mentioned WHO Ministerial Conference. The joint NGO statement was delivered on behalf of the NCD Alliance, Framework Convention Alliance, European Association for the Study of Obesity, European Respiratory Society, Smoke Free Partnership, World Cancer Research Fund International, the International Union Against TB and Lung Disease, and European Public Health Association,

The outcomes of her research study were also presented at the 6th EPH conference in Brussels, 13–16 November 2013.

The ESCD has been actively involved in the PHIRE project (founded by the European Commission, DG SANCO/EAHC, Agreement No. 20091214; Project duration: 09/2010-02/2013). The project coordinator is EUPHA (Dr. Dineke Zeegers Paget) and the ESCD was responsible for evaluation of the tracer project from the field of chronic diseases: "EUCID – European core indicators in diabetes mellitus" (project number: 2005109).

7. Representation of section/EUPHA at conferences and other events

Dr. Iveta Rajnicova-Nagyova, president of the EUPHA section on Chronic Diseases, was the formal representation of EUPHA at the WHO European Ministerial Conference on the Prevention and Control of Noncommunicable Diseases in the context of Health 2020 that took place on 3-4 December 2013 in Ashgabat, Turkmenistan.

7. Outlook for 2014

- Organization: Formation of a section Steering Committee

The following tasks were envisaged for the Steering Committee members:

- 1. Advise the section President and vice-President about issues such as strategy and activities of the section, collaboration with external partners, and the role/position of the section within (developments in) EUPHA
- 2. Support the section President and vice-President with the execution of section related tasks, such as consulting section members on specific topics, preparing the section's annual meeting, and writing news updates for e.g. the EUPHA Newsletter
- 3. Contribute to articles, (position) papers etc. on behalf of the section, at the request of or in consultation with the section President and vice-President
- 4. Represent the section/EUPHA at conferences and other events, at the request of or in consultation with the section President and vice-President and/or the EUPHA office
- 5. Supporting the section in preparation of research grants
- 6. Promoting the section's public health areas of interest
- <u>Information</u>: Next year we plan to continue in all the above-mentioned activities, in particular in distribution of relevant chronic disease material via the EUPHA tools EUPHApedia, EUPHA mailman system and the section's website.
- <u>Projects:</u> We plan to more actively search for the possibilities to be involved in EU projects.
- <u>Workshops/pre-conferences</u>: ESCD plans to organize at least one workshop during the next EPH conference in order to provide a platform for exchange of information, transfer of knowledge and expertise, as well as creation of new partnerships, stimulating involvement in existing projects and planning new projects.
- <u>Publishing</u>: the section will seek the opportunities to encourage its members to publish in the European Journal of Public Health and to prepare statements and reports on behalf of EUPHA.
- <u>Cooperation</u>: ESCD plans to continue in active cooperation with the section's strategic partners such as WHO/EURO Division of Noncommunicable Diseases, and we also plan to develop new partnerships. With regard to EUPHA sections, we plan more intensive cooperation with the EUPHA section on Urban public health and Proposed Section on Public Health Monitoring and Reporting. This cooperation should result in organizing common workshops.
